2. - I also want to express my concern with the school system, juveniles with gang affiliation are infiltrating the school system in urban and even suburbia and rural areas.


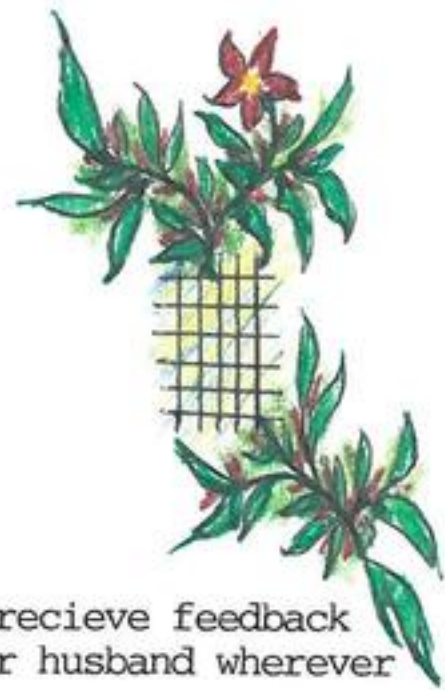
