IN CALIFORNIA, I WAS TRIED/CONVICTED/SENTENCED; BY A WHITE PROSECUTOR, WHITE JUDGE IN RICO CONSPIRACY; ALONG WITH A WHITE JURY IN REVERSE JURY NULLIFICATION COMPLICITY; THEREAFTER, THE CONSPIRATORS DID UNLAWFULLY CONDEMNED ME ^{TO} 16-YEARS OF PRISON ENSLAVEMENT FOR THE BLAMESLESS HE/ASAY, SHE/SAY, NON-FORENSIC CRIMES THAT ACCORDING TO THE TRIAL BOYCOTTING LISTED, DRAFTED NAMED-VICTIM PRETRIAL TESTIMONY WAS/ THAT THE RACIST, WHITE KLANSMEN PROSECUTOR WAS A DAMN LIAR; THE PHANTOM CRIME NEVER EVEN HAPPENED.

ON THE INSTALLMENT PLAN . A). NEEDLESSLY TO SAY AND AS TO BE EXPECTED , BECAUSE MY SKIN IS BLACK. UNDER OHIO'S DEFACTO JIM CROW RULES, I WAS DENIED. ALL REQUESTED WITNESES IN MITIGATION/DEFENSE; IN VIOLATION OF FEDERAL LAW.

I). ALBEIT, I HAD FULLY COMPLIED WITH THE 1992 DATED WRITTEN PAROLE INSTRUCTION AUTHORED BY APA DEPUTY ADMINSTRATOR, GAIL A. PRICE OF INTERSTATE COMPACT OFFICE; AT THE REVOCATION HEARING; THE HEARING OFFICER AGREED WITH ME. BUT STILL REENSLAVED ME AND NOW I AM ON MY EIGHTH-YEARS OF UNJUST REENSLAVMENT DURING MY TWILIGHT-YEARS NO CIVILIZED PEOPLE OR NATION WOULD DESTROY ITS BLAMELESS CITIZEN FOR FANTOM CRIMES AND UNBROKEN RULES. CALIFORNIA: BECAUSE MY SKIN IS BLACK I WAS DENIED A VICTIM AT MY TRIAL TO EXPOSE THE WHITE PROSECUTOR. I HAVE UNLAWFULLY SUFFERED 14-YEARS OF SLAVERY PERSECUTION CRUCIFICATION FOR CON-VICTION OF PHANTOM, NON-FORENSIC, HE/SAY, SHE/SAY, ACCU-SATIONS ; THAT ACCORDING TO THE TWO-YEARS PRIOR TO IN OPEN COURT UNDER OATH, SWORN TESTIMONY OF THE DRAFTED, LISTED, TRIAL BOYCOTTING NAMED-VICTIM; REPUDIATING, DENYING AND DENOUNCING THE SUPREMA-CIST PROSECUTOR'S VICIOUS, VILE LIES OF VICTIMIZATION

FOUND "GUILTY" OF FAILING TO REPORT TO THE ADULT PAROLE AUTHORITY IN 1998. ; AND FOUND "NOT GUILTY" OF FAILING TO REPORT TO THE ADULT PAROLE AUTHORITY, DEPUTY ADMINSTRATOR, GAIL A. PRICE, INTERSTATE COMPACY OFFICER IN 1998. THAT SOUND STUPID DOESN'T IT? SAD BUT TRUE. GUILTY AND NOT GUILTY OF THE SAME OFFENSE. HUMAN LIFE MEANS NOTHING; AND MY BLACK LIFE LESSER THA DIRT UNDER A SHOE. IN THE LAST 21-YEARS ALL HUNDREDS CONTACTED WERE TOO AFRAID TO INVESTIGATE AND REPORT MY LEGAL LYNCHING OUT OF FEAR OF EXPOSING THE RACIAL ESTABLISHMENT. ALL TOO AFRAID TO EVEN TYPE THE PHRASES: " DENIED A VICTIM AT TRIAL "; " DENIED ALL REQUESTED WITNESSES AT A CIVIL HEARING. IN RUSSIA THIS IS ILLEGAL.

THE SOULS OF MILLIONS OF TRUE PATRIOTIC AMERICANS PASS AND PRESENT WANTS TO KNOW WHY? WHY OPB? VIA THE WHITE CONSPIRATOR'S WEAPONIZED CORRUPT, RACIALLY SUPREMACIST CRIMINAL INJUSTICE SCHEME; UTILIZED FOR THE SOLE RACIAL GENOCIDAL PURPOSE OF DESTROYING THE INNOCENT LIFE OF A BLACKAMERICAN PATRIOT. BY CONDEMNING ME TO A CRUEL, INHUMANE TORTUROUS PRISON INTERNMENT. THUSFAR, I HAVE UNJUSTLY SUFFERED 21-YEARS OF AGONIZING SLOW TORTUROUS DYING IN A BARBEDWIRE, STEEL, CONCRETE TOMB; MY LIFE SENSELESSLY ROTTING AWAY WITH NO LIVEABLE END IN SIGHT, WITH ONLY THE OPEN GRAVE AS MY RESPITE. AS PUNISHMENT FOR THESE PHANTOM CRIMES, CRUCIFIXTION PRISON ENLSVEMENT UNTIL DEAD. FOR A BLACKMAN, WHO DIDN'T COMMIT A CRIME & DIDN'T FAILED TO REPORTED PER WRITTEN INSTRUCTION; I MUST DIE FOR THOSE HIGHLY DANGEROUS PUBLIC ENEMY NUMBER ONE INSULT TO WHITE SUPREMACISY. THIS IS JUST BLATANT RACISM; A RACIAL MURDER.
