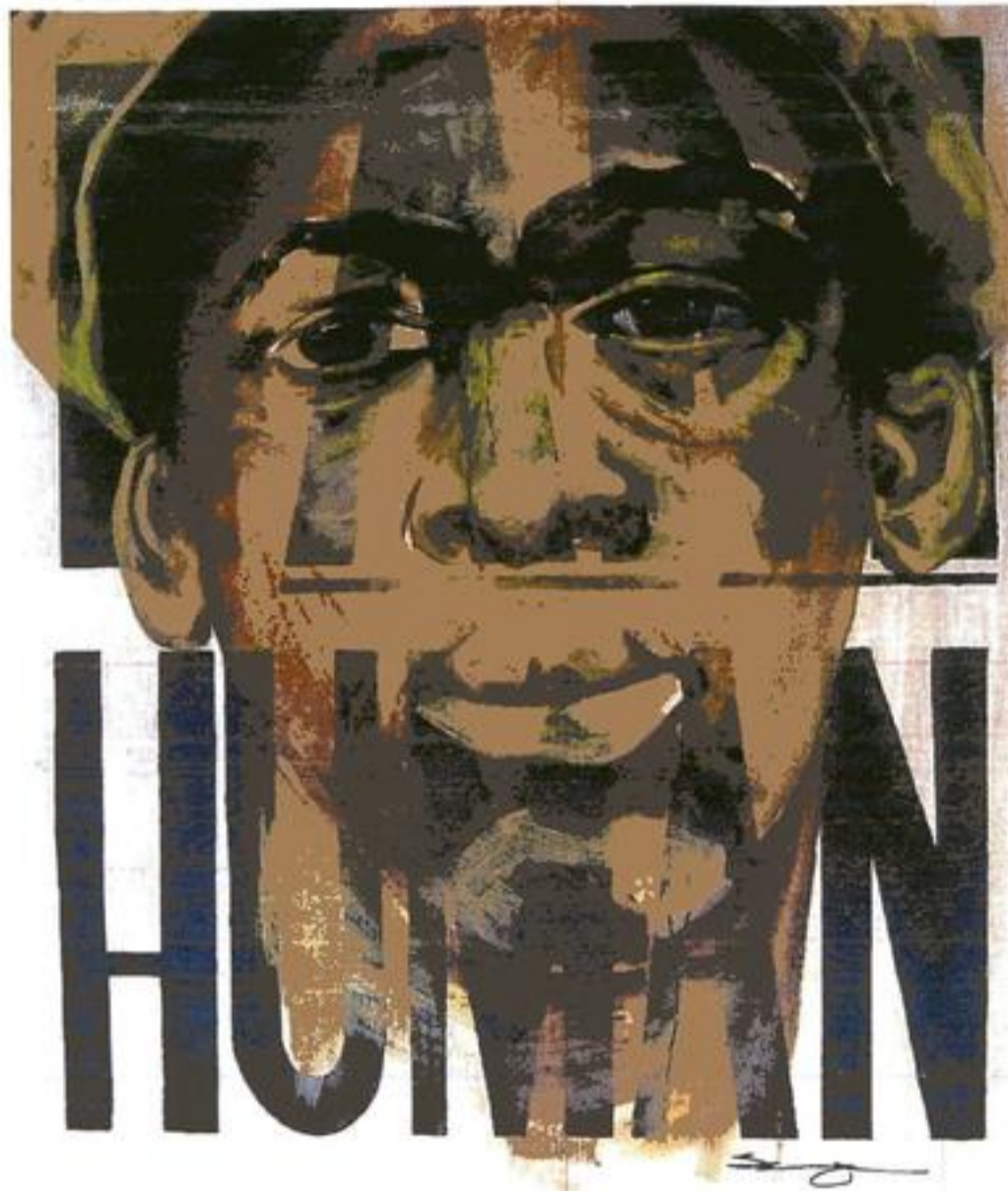

Note to Reader -

during the session, Byron (sa) asked how was this group started, the facilitator Rosas gave an unfactual answer which caused me anxiety in the moment, He said

" Because I felt there was a need for this community to have a space to be more or less expressive .

That was a short edited version of his answer based on my opinion. I, Floyd (g) wanted my silence to do 2 things 1. Register to both Byron (sa) and facilitator Rosas (sa) they both know the 11 year history of this writers aggressive advocacy for all sub-departments within CCR to provide this very program written by this writer.

And 2, for the rest of the group to not be derailed from the primary focus of this particular session.

The focus: What do you think about Chicago Slain Rapper Requesting protective Custody based on his sexual Orientation.

The video served as a liberated fact for foundational purposes, the straight allies in the group provided powerful insight about Rules of prison conduct, Desmond (sa) stated King Von shouldn't address his own fellow convict group to engage the integrity of conduct based on race and street level affiliation, they don't have no structure.

"That's not a leaked video, that's a collusion between active gang members and law enforcement officers, but it looks like King Von in this situation is the only one being called a snitch, especially when whoever is releasing these videos is doing it in hiding, and for self-gain.

King Von could've allowed his anxiety, caused by the social demeaning rejection of his own race to commit suicide like former NFL star Aaron Hernandez, or the many non-famous victims of incarcerated suicides.

The massive prison closet door has been open, and King Von's statement and body language expresses more than a lot of people are willing to acknowledge as a liberated fact, especially his friends, and associates.

For anyone who pretends to not know, at least King Von exposed that the use of sexual orientation in a jail setting would make an impact to whatever degree of safety, or simple bed move he sought. But nobody can pretend not to see the kiss of defiance King Von blew at his adversary, "Bye Lil Josh" is direct, "They tried to let me suck they dick" is direct, and the line about Christians having a problem with gay people is the most important reason for fellow queer inmates to not guess themselves about the intent of religious volunteers, and inmates, and don't get me started on the Bible verses people use to disrespect queer inmates, unchecked within their own subcultures.

Byron (sa) added that by no means was King Von supposed to do what he did and would've been better off defending his own integrity in such a high impact physical environment, because that's Snitchin what he did'.

Floyd (sa) asked the group, is that snitchin, or exposing an injustice because King Von stated a few things of interest nobody knew before he spoke, he revealed his own sexual orientation, which somehow his cellmate knew about and became discriminatory towards him for that reason, and not Gay related matters.

King Von also mentions his cellie was supposed to be a Christian and have problems with gay people, and before King Von said those words only Queer inmates expose that fact because too often Gay members are the ones who are blamed for violence against queer inmates, while prison sub-cultural groups go un-recognized for the same discrimination, specifically religious inmate groups.

Desmond (sa) responded to Floyd comparing what King Von did, to Dr. Martin Luther King, Malcolm and Fidel Castro hours of outspoken discriminatory actions by the U.S. with

"Yeah, but they spoke to their own groups before they got out there, and wasn't speaking behind nobody's back for self-gain."

Byron (sa) said "Nobody is going to accept that comparison, because it's two different things."

Floyd (g) "That's what I mean, sexual proclivity selectivity, exposing ones oppressor is exposing injustice, but when it's queer people exposing the very same acts of injustice perpetrated by fellow Black people working in collusion with law enforcement officers, it's called snitchin? hummmmmmm. WTF?"

The video was replayed for Miss Robinson (T) who came late to session and stated how before the transition, she was a worker in a county Jail in Los Angeles and handled the situation very differently than King Von did.

Requesting a simple cell move could be smooth over with the lack for the need for Deputies to be bogged down with unnecessary paper-work, and often times, cell moves became a ZERO problem situation.

Floyd (G), while disagreeing with all suggestions, at least was able to draw attention to a Nation wide need for Queer inmates to Request Protective Custody, or Request Crisis Bed moves, Administrative Segregation in the first place, to forced exile from fellow convicts.

The focus was not on King Von being a highly regarded Rapper, Street King, and adored by community, a major factor, who's known for getting physical in society and in custody, the focus here was if it is well known that Sexual Orientation is a matter of non-acceptance within our own culture based on mis-education, and hyper-religious proselytation in Africa is a recent example of this truth.

The Sund Blind Company was created for the King Vons of the world who have no place to land in prison and forced into a toxic demeaning de-Raced, de-Cultured, and de-Spiritualizations by our own community, Gay niggaz loved King Von like everybody else.

Not only did we notice no Black officers in the video we also noticed how the officers enjoyed the moment, in equal portions as did King Von's enemies which brings to this liberated fact, so-called solid inmates work with law enforcement from the inside to release what was documented as a Confidential Sexual Orientation safety matter.

Is there a difference between working for the cops, and working with the cops?

Whatever your view is of the King Von situation, you must take into account that nothing happens in custody without the cops being involved, or else sexual orientation would be addressed by, NOT removing the victim, but enforcing state laws about discrimination and Hate Speech connectivity to violence, attempted violence, and threats of violence.

King Von dont strike any of us as playing, and making stuff up to simply get a Bed move.

"They tried to let me suck they dicks", that statement means that Josh wasnt the only one interested in getting a blow job from another man in Jail, thats more than humiliating your enemy because as a gay man myself, that act factors in erection, now what street niggaz in Chicago Jail can get sexually aroused waiting for a turn to get his dick sucked without a gay tone in his body?

I thought people like that wasnt allowed to be in the same custody area with "Real Niggaz", and isnt that forcible Rape? So what is it, get rid of all gay niggaz of the line? OR only the niggaz that dont want to climb into a jailhouse closet to suck the dicks of his closeted enemies?

I have strong family ties in Chicago, and until the King Von tape release, I thought Real Niggaz didnt care about so-called gay shit, and only focused on shit that mattered to their sub-cultural group.

For the true Gay folks in Chicago we feel you, we see you, and you matter, Nationwide, these things shall be addressed. All hail King Von, you knew how it go.
